

## Section 2: Table 9.2.1.(a) Current year Ratio of association membership to meetings in 2015

This table uses the data on international association meetings of type A presented in Table 9.1.1. and also the data on international association membership documented in the database of the *Yearbook of International Organizations*.

Countries are listed in alphabetical order. For ranking, see Table 9.2.1.(b). Only countries with at least 1 international association meeting in 2015, as detailed in Table 9.1.1., are included here.

The first column gives the total number of meetings of type A held in 2015 in the country specified. The second column gives the total number of international associations with members in that country. The third column gives the ratio of meetings to association membership, where meetings has the value of "1".

**For example:** for 760.5 international associations with members in Albania there was 1 international association meeting in 2015 in Albania; for 125.3 international associations with members in Bulgaria there was 1 international association meeting in 2015 in Bulgaria.

The international associations included here are classified in the *Yearbook of International Organizations* under these types:

- A= federations of international organizations
- B= universal membership organizations
- C= intercontinental membership organizations
- D= limited or regionally defined membership organizations
- E= organizations emanating from places, persons or other bodies
- F= organizations having a special form, including foundations, funds
- G= internationally-oriented national organizations
- K= subsidiary and internal bodies
- N= national organizations
- R= religious orders, fraternities and secular institutes

**Meetings counted under the heading "A" are "Meetings of international organizations" and meet all the following criteria:**

- meetings organized or sponsored by "international organizations", i.e. international non-governmental organizations (INGOs) and intergovernmental organizations (IGOs) that are included in the UIA's *Yearbook of International Organizations* (see the Introduction "What is an 'international organization'") and whose details are subject to systematic collection and updates on an annual basis by the UIA
- with at least 50 participants, or number of participants unknown

**For example:** for 4.4 international associations with members in Singapore there was 1 international association meeting in 2015 in Singapore ; for 52.4 international associations with members in Macau there was 1 international association meeting in 2015 in Macau.
